### Part C State Annual Performance Report (APR) for 2012-2013

#### **Overview of the Annual Performance Report Development:**

The State Annual Performance Report is to be submitted annually in accordance with the 20 U.S.C. 1416(b)(2)(c)(ii)(II) and 1442. The first APR was submitted February 1, 2006, and has been provided to the Office of Special Education Programs (OSEP) each year since that date. In the February 3, 2014, APR submission, the State is required to provide a description of the process the State used to develop the APR. The descriptions must include how and when the State will report annually to the public on: 1) the State's progress and/or slippage in meeting the measurable and rigorous targets found in the State Performance Plan (SPP); and 2) the performance of each local educational agency located in the State on the targets in the SPP.

#### Process Used to Develop the APR

The Nebraska Department of Education (NDE) and Nebraska Department of Health and Human Services (NDHHS), acting as co-lead agencies (a.k.a. the Co-Leads), are responsible for ensuring that Part C of the Individuals with Disabilities Education Act (IDEA) is fully implemented for all infants and toddlers with disabilities and their families through the Early Development Network (EDN). Monitoring is done through the state's 28 Planning Region Teams (PRTs). The Planning Region Teams function as Nebraska's local interagency coordinating councils with representatives from services coordination, social services, the medical community, school districts, families, and others involved in meeting the needs of children and their families. The Planning Region Teams assist in conducting Child Find, public awareness, professional development, family involvement and address gaps and barriers to services at the local and regional level.

The monitoring process is comprehensive, taking into account multiple sources of data to gauge the results of Early Intervention and special education services and supports. The NDHHS and NDE Monitoring Protocols guide the review of files and other factors that indicate compliance with IDEA Part C requirements. The data gathered is analyzed to evaluate services coordination, early intervention services in natural environments, Child Find, the Individual Family Service Plan (IFSP) process, early childhood and family outcomes, effective transition and family rights.

NDE staff conducts on-site monitoring activities involving school districts on a five-year cycle. In addition, school districts carry out specific activities each year as part of the "Improved Learning for Children with Disabilities" (ILCD) process that serves as a guide for local school districts to evaluate themselves and the services they provide for children with disabilities. The ILCD improvement activities are designed to direct school districts toward appropriate practices to decrease the likelihood that they will be found out of compliance when monitored by NDE.

NDHHS staff monitors Services Coordination every three years. IFSP files and other records maintained by Services Coordinators are reviewed for compliance with IDEA and Medicaid. Information gathered through the monitoring by NDE and NDHHS is shared for use in the development of the APR and the issuance of annual determinations to school districts. The Co-Leads, made up of representatives of the two agencies, jointly provide training and technical assistance to providers across the state regarding state and federal rules and the other issues involved in compliance monitoring.

The number of infants and toddlers verified with a disability is collected annually through the NDE Nebraska Student and Staff Record System (NSSRS). Information is entered in NSSRS by school district

personnel. Referrals to EDN are collected through the CONNECT system (Coordinating Options in Nebraska's Network through Effective Communication and Technology) managed by NDHHS.

Information is entered on CONNECT by Services Coordinators who work with children birth to age three. The CONNECT system also allows Services Coordinators to access information regarding other services the child is receiving. Data from both systems are analyzed and sent to the Early Development Network for review. Data is also obtained through family, provider/Services Coordinator, and Planning Region Team member surveys.

Outcome data on children birth to three is gathered through the statewide early childhood assessment system known as "Results Matter." Family outcome data is collected via a statewide survey of all Part C families. Positive social-emotional development has been fostered and evaluated through Nebraska's participation in the Centers for Social and Emotional Foundations for Early Learning (CSEFEL) program. In addition, the state Early Childhood Interagency Coordinating Council (ECICC) and the State Special Education Advisory Council (SEAC) examined and provided input concerning early childhood outcomes, program quality initiatives, family surveys and identification of gaps and barriers in the early childhood system.

#### **Reporting to the Public**

Nebraska EIS will use the Early Development Network website to annually report to the public on Nebraska progress and/or slippage in meeting the State Performance Plan (SPP) measurable and rigorous targets. The Individualized Family Service Plan (IFSP) checklist file review for Improving Learning for Children with Disabilities (ILCD) gathers data regarding the receipt of early intervention services on IFSPs in a timely manner.

In FFY 2012, seventeen (17) of the Planning Regions participated in an IFSP file review for a total of 166 files. All 166 files (100%) were in compliance with the IFSP completed in a timely manner.



#### Nebraska Child Outcome Assessment Process

In 2006, NDE selected three research-based, authentic online child assessment systems including: Teaching Strategies Creative Curriculum, High/Scope Child Observation Record (COR) and Assessment, Evaluation and Program System (AEPS). In the spring of 2011, the state Results Matter Task Force recommended that NDE adopt a single child outcome measurement system. Teaching Strategies GOLD, a seamless birth through kindergarten system, was selected. NDE required that by Fall 2012 all school districts in Nebraska would be implementing GOLD. School districts were allowed a two-year window in which to transition to GOLD from the three previous systems.

A single system was adopted in order to improve the quality, reliability and validity of the data; streamline the reporting system, and simplify the infrastructure needed to support the implementation process. Scientifically-based cutoff scores defining comparability to same-aged peers were determined by Teaching Strategies (updated in 2011), which maximizes the validity of the data used to report on each of the OSEP early childhood outcomes. NDE is the state administrator of the online subscription agreements between the school districts and Teaching Strategies.

As of August 1, 2013 all school districts were using GOLD; however, some children still had entry data in either COR, Creative Curriculum, or AEPS. Children whose entry data was completed on any of the three "old" assessment systems was not used for this report. This decision was made last year in preparing the FFY2011 APR, when it was found that the conversion scores imported into GOLD from the other assessments were not equivalent. This year, we have an increase in number of children exiting over last year, and expect it to be higher in following years when all children's entry and exit data will be on GOLD.

A total of 499 children had entry and exit data during FFY 2012.

- 70.7% of the children were male.
- 79.6% were white and 14.6% were Hispanic.
- 89.8% of the children had English as their primary language.
- At exit, the majority (92.6%) of the children were 36 months of age or older.

#### Revised Measurable and Rigorous Targets for Children Exiting in FFY 2010 - FFY 2016

Nebraska child progress data from 2008-09 and 2009-2010 were re-analyzed in Fall 2010 using the new conversions to determine differences and trends across those two years. Based on that analysis and the recommendations of the Results Matter Task Force, the baseline and targets were adjusted as follows:

#### **Strategies to Maximize Data Collection**

NDE implemented a number of technical assistance strategies this past year to support the collection of data for OSEP reporting. In order to minimize missing data, NDE initiated a data checking process during Fall 2012 and Spring 2013. District data was provided to each district for review and validation of accuracy. The review of the data disclosed missing data. School districts completed follow-up steps based on state technical assistance, e.g. providers were requested to finalize their data, administrators completed correct online exit procedures, etc. This process resulted in clarification of procedures and assessment practices at the district/child level. In turn, the process resulted in an increase in the number of children with usable exit data reported for FFY 2012.

# Discussion of Improvement Activities Completed and Explanation of Progress or Slippage that occurred for FFY 2012:

None of the targets were met for 2012-2013.

The targets for FFY 2012 were established in FY 2010, based on assessment information from the three state-identified child assessments that were used at that time. Since Nebraska is now only using GOLD, there is a need to re-establish the targets. It is planned that new targets will be established in FFY 2013, when Nebraska will have two full years of statewide GOLD implementation. This will provide more valid and adequate data on which to base new targets.

FFY 2012 is the first year that child outcomes are based only on GOLD entry and exit data. Prior to this the child outcomes data was based on data from the three assessments previously used: AEPS, HighScope COR and GOLD. When the data from FFY2012 was first analyzed in September 2013, it was noted that the findings were quite discrepant from previous years. Summary Statement 1 and Summary Statement 2 results were significantly lower than previous year's results and targets. In FFY2011, there was limited GOLD entry and exit data, so when combined with the other two assessment data, GOLD results did not impact the overall findings. The higher entry/exit scores on AEPS and COR offset the lower numbers on GOLD.

For the FFY 2012 APR, the statewide family survey was conducted in the spring of 2013 with all of families in the state who had received early intervention services from July 1, 2012 to June 30, 2013.

Out of the 1417 hand-delivered Part C family surveys distributed, 930 surveys were returned, yielding a 65.5% response rate. From this total of 930 surveys, 928 had useable responses. This is a slight decrease by 14 useable responses from the previous year. The percentages reported are calculated as the percent of families whose measures are at or above a standard that is specific to each Indicator (Indicator 4A, 4B, and 4C). The measures are based on the Impact on Family Scale (IFS). For this sample, the Rasch Analysis was used and the scale reliability was estimated at .88. The mean IFS measure was 730.5.

Applying the standard adopted by Nebraska Part C, corresponding to measures of 538.9, 555.9, and 516.1 for sub-indicators 4a, 4b, and 4c, respectively, the percent of agreement by surveyed families to be reported to OSEP are:

### Discussion of Improvement Activities Completed <u>and Explanation</u> of Slippage that occurred for FFY 2012:

The state continues to meet the targets for Indicators 4A, 4B, and 4C. The state attributes meeting the targets to a strong belief in the importance of family involvement all areas in Early Intervention. The state is pleased to report progress on all three Indicators. Additionally, from 2011-2012 to 2012-2013, the IFS Mean rose almost 17 points on a scale ranging from 200 to 800 points.

#### Representativeness:

Based on highly successful return rates in past years, Nebraska continued to use a personalized introductory letter to families before delivering the survey, a follow-up postcard to families, and personal contacts by local representatives to remind families to return the survey. This year the return rate is 65.5%; approximately 2.5% higher than last year.


Nebraska also attempted to ensure representativeness by hand-delivering the survey to every family enrolled in Part C. Families identified as Spanish-speaking received all survey materials translated into Spanish and a toll-free phone number that was answered by a Spanish translator who could answer questions or read the survey to the family. A separate toll-free phone number was provided through PTI-Nebraska for families who speak other languages or those needing special assistance in reading and/or understanding the survey questions. The Nebraska survey also asks families to identify their race/ethnicity, child's age, length of time in program, and if the family had selected to use a DHHS Services Coordinator.

Additional analyses conducted by Dr. Batya Elbaum revealed:

- There were no statistically significant differences across groups for the following variables:
  - o child's age at time of survey completion,
  - length of time in early intervention,
  - o receiving a questionnaire in Spanish, or
  - o race/ethnicity.
- Statistically significant differences were found across Planning Region Teams (PRTs). PRTs with the highest IFS scores were statistically different from PRTs with the lowest IFS scores.
- The Mean IFS was significantly higher for families who self-reported that they had a Services Coordinator (M = 735) than for those who self-reported that they did not have a Services Coordinator (M = 685).
- Differences among families living in a large city, town/suburb or rural area were significant. Families in areas defined as town/suburb had the highest mean IFS measure (M = 745) then large city (M = 726), and then followed by rural (M = 703). A possible explanation is that the rural population is less likely to have the opportunity to receive services with their peers and the urban population has a higher likelihood of being disadvantaged. Both of these factors may lead to the suburban population being most satisfied.
- Families who agreed with the survey item, "My child receives services with children without disabilities of the same age" had a significantly higher mean IFS measure (M = 759) than families who disagreed (M = 649).

- In partnership with University of Nebraska-Lincoln (UNL) Center for Children, Families, and the Law, the State Part C Coordinators made presentations to raise awareness about the Early Intervention process in conjunction with Helping Babies from the Bench. This statewide training targets judges, medical and mental health personnel, Child Protection Services personnel, attorneys, families, special education staff and Services Coordinators.

In FFY 2012, 17 Planning Regions were reviewed for a total of 146 files. The files reviewed included those infants and toddlers who were referred and determined eligible for early intervention services. A total of 123 infant and toddler files showed the IFSP to be in compliance with the 45-day timeline. In 23 of the files the 45-day timeline was not met; of these, 17 files were documented to indicate delay was due to exceptional family circumstances. The Co-Leads notified the EIS programs in writing concerning the findings of noncompliance and the requirement that the noncompliance be corrected as soon as possible but in no case more than one year from identification. The State has verified that the EIS programs are correctly implementing the specific regulatory requirements and have ensured that the child received an initial evaluation, assessment and IFSP meeting, although late, and the services listed on the IFSP within a timely manner from the IFSP meeting.

# Discussion of Improvement Activities Completed <u>and</u> Explanation of Slippage that occurred for FFY 2012:

Seventeen of the Planning Regions participated in the file reviews in FFY 2012. For FFY 2012, 95.9% of the files reviewed were in compliance regarding the MDT/IFSP timeline.

In each case of noncompliance, the Co-Leads notified the EIS program in writing concerning the finding of noncompliance and the requirement that the noncompliance be corrected as soon as possible, but in no case more than one year from identification. In the regions where the 45-day timeline was not met, the Co-Leads provided technical assistance on appropriate documentation for delay in meeting the IFSP 45-day timeline. As the 17 Planning Regions monitored comprise a majority of the total in the state (28), it appears that compliance with the 45-day timeline is at a reasonably high level. Because this timeline has such a significant impact on the provision of services to infants and toddlers, the Co-Leads believe that it is important to continue training to ensure that all EIS programs correctly implement the specific regulatory requirements and have strategies in place to ensure compliance. The Co-Leads will continue to conduct additional professional development as outlined under the improvement activities.

Slippage can be attributed to:

In cases where the 45-day timeline was not met, it was exceeded only by a few days. The State has verified that the EIS programs are correctly implementing the specific regulatory requirements and have ensured that the child received an initial evaluation, assessment and IFSP meeting, although late, and the services listed on the IFSP within a timely manner from the IFSP meeting.


Fifteen of the Planning Regions participated in the IFSP file reviews in FFY 2012. Significant improvement was demonstrated in 8A and 8C since FFY 2011.

In each case of noncompliance, the Co-Leads notified that EIS program in writing concerning the finding of noncompliance and the requirement that the noncompliance be corrected as soon as possible, but in no case more than one year from identification. In the regions where transition plans did not contain appropriate documentation of transition plan steps and services, the Co-Leads provided technical assistance on appropriate documentation of transition plans for children exiting Part C. The requirements and appropriate documentation of transition plans for children exiting Part C will continue to be a training topic to ensure that all EIS programs correctly implement the specific regulatory requirements and have strategies in place to ensure

compliance. The Co-Leads will continue to conduct additional tasks as outlined under the improvements activities. The state has verified that each EIS program is correctly implementing the specific regulatory requirements and ensured that all children, who had not exited Part C, were provided with appropriate transition plans documenting all necessary transition steps and services prior to the children exiting Part C.

The improvement activities outlined for FFY 2012 were implemented as follows:
