## The Hypothesis is



IF the state provides supports and training to the PRT's to:

(1) implement authentic child and family assessment (RBI),

(2)write functional and meaningful child and family outcomes, and

(3)implement routines-based home visits,

AND the PRT's implement these strategies with fidelity,



THEN Nebraska's federal child and family outcomes will improve.







## Review of Part C RDA Strategies

The RBI (Routines Based Interview) as the child and family assessment,

Writing functional child and family outcomes derived from a family interview, and

Quality home visits based upon family routines.

A 3-pronged intervention strategy





#### Why these strategies



1.are supported by current research about how young children grow and learn,



2. are known to positively impact the provision of services to children and families based on a representative sample of Nebraska's regions as well as implementation in other states, and



3. meet new Rule 52 and IDEA legislation.
